## CPBE100 College Park Scholars: Business, Society & the Economy First-Year Colloquium (1 Credit)

Introductory colloquium: Examination of issues related to business, society and the economy.

**Restriction:** Students must be matriculated into the College Park Scholars Business, Society & the Economy (CPBE) program.

#### CPBE101 College Park Scholars: Business, Society and Economy First-Year Colloquium II (1 Credit)

The course is the second of three colloquia for the BSE Scholars program scheduled for their second semester (Spring). This colloquium is designed to emphasize the entrepreneurial focus of the BSE program by giving students the opportunity for practical, real-life and personal exposure to entrepreneurial activities.

Prerequisite: CPBE100.

**Restriction:** Students must be matriculated into the College Park Scholars Business, Society & the Economy (CPBE) program.

# CPBE200 College Park Scholars: Business, Society and Entrepreneurship: Second-Year Colloquium I (1 Credit)

The third of three colloquia for the BSE Scholars program is designed to expose and engage students in real-life and real-time entrepreneurial challenges. BSE partners with two organizations that bring current and relevant challenges to the class. Students work in small teams to explore a highly experiential start-up challenge.

Prerequisite: CPBE101.

Restriction: Must be enrolled in the College Park Scholars Business, Society, & the Economy (CPBE) program. Credit Only Granted for: CPSP218B or CPBE200. Formerly: CPSP218B.

#### **CPBE225 Enterprise Communications (3 Credits)**

Examines basic interpersonal communication processes within written and oral channels, with practical applications for the business environment.

Prerequisite: CPBE100.

**Restriction:** Must be enrolled in College Park Scholars' Business, Society and the Economy (CPBE) program. **Formerly:** CPSP220.

## CPBE230 College Park Scholars: Business, Society & the Economy Internship Practicum (1-3 Credits)

Supervised internship project in an area related to business, society and the economy.

Prerequisite: CPBE100.

**Restriction:** Students must be matriculated into the College Park Scholars Business, Society & the Economy (CPBE) program.

# CPBE240 College Park Scholars: Business, Society & the Economy Service-Learning Practicum (1-3 Credits)

Supervised Service-Learning project in an area related to business, society and the economy.

Prerequisite: CPBE100.

**Restriction:** Students must be matriculated into the College Park Scholars Business, Society & the Economy (CPBE) program.

# CPBE250 College Park Scholars: Business, Society & the Economy Research Practicum (1-3 Credits)

Supervised research project in an area related to business, society and the economy.

Prerequisite: CPBE100.

**Restriction:** Students must be matriculated into the College Park Scholars Business, Society & the Economy (CPBE) program.

#### **CPBE270** Impacts of Globalization (3 Credits)

Introduces students to key global concepts, discusses a range of perspectives on globalization and cultural competence, and offers an applied learning experience.

Prerequisite: CPBE100; or by permission.

Cross-listed with: HONR298A.

**Restriction:** Students must be matriculated into the College Park Scholars Business, Society & the Economy (CPBE) program; or by permission.
