The University of Maryland (UMD) acknowledges that not all students fit into the freshman or transfer applicant categories. There are several unique application processes for such audiences. Golden Identification (Golden ID) Program

The Golden ID Program allows eligible senior citizens to take advantage of the wide variety of course offerings at the university. To be eligible to participate, the individual must be 60 years of age or older, a legal resident of the state of Maryland and retired (not engaged in gainful employment for more than 20 hours a week).

To participate in the Golden ID program, students must submit an undergraduate admissions application. If admitted to the university, students should follow the normal enrollment process for the application type submitted. Students must pay an administrative fee for each semester registered.

Non-Degree Seeking Students

Students interested in taking courses at UMD without pursuing a degree must apply for admission as non-degree seeking students using the undergraduate admissions transfer application (<https://admissions.umd.edu/apply/application-checklists/transfer-application-checklist/>).

Non-degree seeking students who have already received a baccalaureate degree may enroll in undergraduate courses for which they possess the necessary prerequisites. Credits earned while enrolled as a non-degree seeking student cannot be applied to a graduate program at a later date. Students who wish to take courses at the graduate level (600 and above) must contact the Graduate School for information concerning admission requirements for Advanced Special Student status.
